<u>Notes</u>

1. The exchange rate between the Zambian kwacha (ZMW) and the Euro (EUR) has been very volatile during the past two years. The accounts are made up on the basis of the exchange rate at the end of the financial year (31st December). This results in exchange differences from one year to next (balance sheet) as well as on transfers from ZAP's EUR account in the Netherlands to its ZMW account with Standard Chartered Bank in Zambia. These differences were much lower in previous years and therefore were included under "Other general expenses".
